Stated Clerk Report Classis Heartland, August of 2021

Since I have only been part of Classis Heartland for a little over a year, I thought I would briefly introduce myself before reporting on my work.

About Me: I serve as the pastor of Sanborn Christian Reformed Church, and moved to northwest lowa after spending eight years pastoring the only CRC in Vermont. Shortly after moving to Sanborn last year, I was asked to consider serving as the clerk of our classis. I began this position on April 1st of this year and this is the first classis meeting agenda I have put together. I am blessed to be serving with you in Classis Heartland and welcome your phone call or email if I can be helpful to you or your church.

Meeting Agenda: One thing I have tried to do in collaboration with the CIC and Classis Program Coordinator, Pastor Kevin Muyskens, is put the agenda in the order we plan to address our business. In other words, I am trying to make the agenda and the order of the day one and the same. In so doing, I have organized our business into three categories. First we will address matters that churches are bringing directly to classis (an overture, a request to begin a commissioned pastor process, an examination of a candidate for the Ministry of the Word, etc). Second, we will address business brought by our committees of classis, including ministries they work with (ministry leader reports, classis budget, elections of new committee members, etc). Third, we will receive and respond to reports from our denomination. After each of these sections, we will spend some time in prayer and therefore pray for our congregations, our servants of classis, and our denomination.

Other Tasks Accomplished: Since the last classis meeting, I have...

- 1. met with Rev. Bob Drenten (previous clerk) to review my duties and records to maintain, and been in touch with him occasionally to ensure a smooth transition process.
- 2. forwarded requested correspondence from classis committees and the denomination.
- 3. reviewed recording of online meeting for classis clerks on July 15, 2021.
- 4. participated in meetings of the Classis Interim Committee, Classis Nominating Committee, Classis Education Committee, and Classis Stewardship Committee.
- 5. processed the ministerial credentials of Rev. Scott Van Voorst after he accepted a call to Cornerstone Prison Church and of Rev. Brian Hofman upon his acceptance of a call to Calvin CRC.

Future Plans: I plan to attend a clerk training event out of state on January 5–7, 2022. I also still need to move paper records to Sanborn CRC.

Respectfully submitted, Rev. Phillip Westra Overture: Adopt all the recommendations from the report from the Committee to Articulate a Foundation-laying Biblical Theology of Human Sexuality.

I. Background:

Synod 2016 adopted the following Motion:

That synod appoint a new study committee to articulate a foundation-laying biblical theology of human sexuality that pays particular attention to biblical conceptions of gender and sexuality. The central aim of this theological task will be to provide concise yet clear ethical guidance for what constitutes a holy and healthy Christian sexual life, and in light of this to serve the church with pastoral, ecclesial, and missional guidance that explains how the gospel provides redemptive affirmation and hope for those experiencing sexual questioning, temptation, and sin" (Acts of Synod 2016, pp, 919–920).

We appreciate the sizable undertaking this study committee has completed and delivered in their report. Providing an Executive Summary of this report proved to be valuable as it allowed many more members of our councils and congregations to engage in the fruit of this labor. The report leads the reader to embrace the truths of Scripture and engage our fallen world with an empathic posture. The articulated worldview, biblical exegesis, lists of resources, pastoral wisdom, other perspectives, and topical studies will serve Christ's church as it continues to engage a world that finds Scripture's teaching about sexuality to be implausible. By God's grace, the church will be the place people find their true identity in Christ and follow God's Word when the idolatries of sexual immorality leave people empty and the strongholds of worldly sexual ideologies fall.

We do not have anything to contribute that alters or challenges the conclusions of this report. We simply wish to add support to the argument made in section XVI regarding Confessional Status. Two books published by Faith Alive about the Heidelberg Catechism, Comfort and Joy: A Study of the Heidelberg Catechism by Andrew Kuyvenhoven and Our Only Comfort: A Comprehensive Commentary on the Heidelberg Catechism by Fred. H. Klooster, give further support to the report's statement about Heidelberg Catechism Q&A 108. Addressing this topic on page 146, the report states the following. "By the word "unchastity" the catechism intends to encompass all sexual immorality, including homosexual activity."

After establishing marriage "as a lasting bond between one man and one woman" Kuyvenhoven goes on to say that "Many people disagree with this Christian teaching and claim that consenting adults may choose a different arrangement for their sexual relationship. But if sex and marriage have been given by God, we will have to live by the rules he established, or we will deeply hurt ourselves and each other. And God will punish us for breaking his laws" (Comfort and Joy, 240). He also writes, "Christians must be very alert to withstand the call for "sexual freedom" because it will lead us into terrible bondage" (Comfort and Joy, 242). According to Kuyvenhoven the term "unchastity" in answers 108 and 109 of the catechism refer to sexual relations outside the marriage of one man and one woman, and we must resist "sexual freedom" that entices us toward such activities.

Klooster makes a similar statement when he writes that "In this commandment God singles out adultery as the most serious of the sins of unchastity while also forbidding all degenerate lusts, whether found in married or unmarried persons" (*Our Only Comfort*, 1006). He then equates "unchastity" in answers 108 and 109 of the catechism with the term "sexual immorality" in Ephesians 5:3, 1 Thessalonians 4:3, and 1 Corinthians 6:18. He clearly sees 1 Corinthians 7:2 as the state where sex is ordained by God, where "each man should have his own wife, and each woman her own husband" (*Our Only Comfort*, 1007). Sexual activity outside such a marriage is

"unchastity" or "sexual immorality." Therefore, both Klooster and Kuyvenhoven offer further support to the conclusion reached in section XVI of the report on page 148, "that the church's teaching on premarital sex, extramarital sex, adultery, polyamory, pornography, and homosexual sex already has confessional status."

II. Overture:

The council of Sanborn Christian Reformed Church of Sanborn, Iowa overtures Synod 2022 to adopt all the recommendations from the report from the Committee to Articulate a Foundation-laying Biblical Theology of Human Sexuality.

Grounds:

- 1. The study committee ought to be commended for meeting the mandate of Synod 2016 by engaging the breadth of our sexual brokenness, a sensitive and controversial matter, guided by Holy Scriptures and our Reformed Confessions.
- 2. This report is helpful and important for our congregations as we struggle to minister with truth and grace in a society where secular norms are constantly changing.
- 3. If we promote as godly behavior what Scripture clearly and consistently condemns (Leviticus 18:6–24, Leviticus 20:10–24, Romans 1:24–27, 1 Corinthians 6:9–10, Ephesians 5:3–5, 1 Thessalonians 4:3–8, and 1 Timothy 1:9–11), we do so to our own detriment and invite God's judgment.
- 4. As argued in the report and supported above, it is clear what the Bible means by "sexual immorality" and what the Heidelberg Catechism means by "unchastity." Violations of sexual purity outlined in this report, therefore, ought to continue guiding the faith and life of the church with "confessional status."
- 5. It is imperative that we remain united by the biblical teachings expressed in this report to remain united in our covenant together as the Christian Reformed Church of North America.

- G. Is committed to the mission task of the church and supportive of local and world wide evangelistic endeavors
- H. Has administrative skills and leadership abilities which can challenge and organize people for ministry
- I. Is desirous of continuing his education and training in areas that relate to the ministry including worship, preaching, evangelism, discipleship, leadership, and pastoral care through attending conferences, classes, training programs and personal reading

Assigned Text – Philippians 2:12-13 (Reading verses 12-18)

To be preached at Hope CRC, Hull on September 19, PM Service

If I was from another church in the Roman Empire, like say Ephesus or Corinth, and I read this letter, I would probably be like, "gross get a room." Well, okay maybe not those words exactly but a similar sentiment. Paul starts this section with "Therefore, my dear friends." Other translations read, "my beloved." The letter the church of Philippi has a different feel to it than the other letters; it is kind of a rarity for Paul. Paul is actually fairly pleased with this congregation. Paul does address a couple of issues in the letter, but by and large he is well pleased with the people of this church. Most other letters from Paul to churches have a lot more corrective language in them.

To understand the tone of the text for this evening, let us look a little bit at the background to the letter and the church in Philippi.

In Acts 16, Paul travels to Philippi in Macedonia with Silas, Timothy, and Luke. Paul himself starts the church in Philippi after meeting Lydia and a number of women worshipping by a nearby river. From the start of this church, Paul has a deep connection to the people there. Paul and Silas were arrested and put in prison, giving them the chance to evangelize a jailer, growing the church while imprisoned.

Paul's relationship with the church of Philippi continued even after he left. In Philippians 2:25 we learn that the Philippian church sent a man by the name of Epaphroditus to help Paul. Epaphroditus likely helped take care of Paul's needs while he was in prison. In Philippians 4:14-18 we see that the Philippian church sent financial gifts to Paul on several occasions. This money was used to support Paul's needs and aid the ministry. Paul is genuinely pleased with the with the church in Philippi, unlike many of Paul's letters that deal with serious issues within the

church. This gives us a better understanding of where Paul is coming from in the verses we will be examining tonight.

As Paul says in verse 12, "Therefore, my dear friends, as you have always obeyed – not only in my presence, but now much more in my absence," he is not admonishing them, but commending them for their obedience. The church of Philippi had been obedient to Paul's teachings and had obeyed God's commands while he was there. Even as Paul has left and moved on to other ministry, they have continued to be obedient. Paul encourages the believers in Philippi to continue in that obedience. Paul probably does this because he has seen other churches lapse in his absence; we think of all those other letters that Paul wrote that were not so gentle. Paul wants to protect the church of Philippi from making similar mistakes to what other churches have made.

We see that Paul is addressing the community of the church as a whole in this letter and in these particular verses. This is less about individual obedience, although that is important, but obedience to God's Word as a community of believers. Paul is encouraging them to work together, helping one another persevere in obedience.

This is evident in verses 14-18. In verse 14 Paul calls the believers to not grumble or argue with each other. In verse 15 Paul demonstrates that this is for the purpose of being a shining light in a "warped and crooked" world. This is for the purpose of drawing others into the body of believers as a place of unity and peace with God. Paul encourages the church of Philippi to continue striving toward obedience as a community of believers.

Continuing in verse 12 Paul writes, "continue to work out your salvation with fear and trembling." This is a phrase that could very easily be misunderstood. To misinterpret this, we place a heavy burden upon ourselves, but to properly interpret this we see that the burden is lifted

from our shoulders. We might wrongfully see in this phrase that we need to cling tightly to our salvation so that we do not lose it. We have to keep working in order to earn the right to keep it. We stand before God with fear and trembling, fear and terror thinking he will rip it from our hands the moment we make the first mistake, the moment we commit any sin. This would be to misinterpret the text and place a huge and unnecessary burden upon ourselves.

In our human tendency, we tend to give ourselves these burdens. Sure, we believe in Jesus, but we have to follow a strict regimen of bible reading, prayer, and attending church. If we just keep these practices up, God will love us and we can feel assured of our salvation. The burden of our assurance, maybe not faith, but assurance is placed on our own shoulders.

This is not what Paul has told the church of Philippi. Paul, while with them, told the jailer in Philippi, the night he was in prison, where assurance of salvation comes from. Acts 16:30-31, "He then brought them out and asked, 'Sirs, what must I do to be saved?' They replied, 'Believe in the Lord Jesus, and you will be saved—you and your household.'" Paul taught them the gospel. The gospel tells us that we are saved by faith in Jesus Christ and our assurance is in Christ. Again, Paul in Ephesians 2:8-9, "For it is by grace you have been saved, through faith—and this is not from yourselves, it is the gift of God—not by works, so that no one can boast." If works do not save us, then works do not earn us the right to keep our salvation. Salvation is by faith alone, a gift from God Most High, and we can rest assured in God's grace and not our works.

Paul's use of the word salvation in this text is not what we generally define or describe as salvation. Salvation can be split into two parts in a sense, two very connected parts. The first is the moment of conversion, the second is the life lived after. The moment of conversion, the moment you are brought into the family of God is called justification. Justification is a one-time

event where we are declared righteous before God because of Christ's sacrifice for us on the cross and the faith we have received from God. This cannot be taken from us. As we stand before the Lord in fear and trembling, it is not that we have terror of losing this gift of salvation, but that we are in awe of God's grace and mercy. Paul emphasizes our assurance in Romans 8:38-39, "For I am convinced that neither death nor life, neither angels nor demons, neither the present nor the future, nor any powers, neither height nor depth, nor anything else in all creation, will be able to separate us from the love of God that is in Christ Jesus our Lord."

When we are declared innocent before the Lord by faith through Jesus Christ, God declares that we are his. We do not cling to our salvation, but God holds it for us and never lets it go. When we typically think of salvation, this is what we mean, that moment of conversion. Paul is not telling us to work to earn that conversion or hold onto that conversion. Paul is referencing the other aspect of salvation, which is a life lived in faith.

Life after conversion consists of living in relationship with God, growing closer to him, and serving the Lord out of deep gratitude. Through this life we become more and more Christlike, never perfect, but greater reflections of Christ in this world. God does this through his Spirit working in us to draw us away from sin and into his will for us. This is the life-long process that we call sanctification. God setting us apart from the world, to have new life, and to live to glorify him. This is what Paul is referencing when using the word salvation in verse 12. Not working out our conversion, but working out our life-long process of living out our God-given faith. The burden of this does not fall upon you here either. That is not to say we do not have some responsibility, but God still carries the burden of our sanctification.

That is what Paul teaches us in verse 13, "for it is God who works in you to will and to act in order to fulfill his good purpose." God's Spirit who dwells in us through faith is at work in

us to sanctify us. This verse echoes what Paul stated to the Philippian church in chapter 1:6, "being confident of this, that he who began a good work in you will carry it on to completion until the day of Christ Jesus." God is at work in us until the day we pass from this life to next or until Christ comes again. God's Spirit works in us to change our wills so that our desires are for him rather than for the things of this world. Even after we are brought into the family of God our earthly desires still wage war for our time and energy, drawing us into sinful acts of rebellion. Thanks be to God that we can be assured of our salvation, but the conflict between our new life and our old self keeps raging on.

This is where we hold some responsibility. It us up to us, with the Spirit of God working in us, to remain connected to our relationship with God. If the seed of faith is going to grow within us, we need to remain connected to the only nutrients, sunlight, and water that can cause it to grow. God is the only source we can use for our faith to grow. As we build our relationship with the Lord, our faith continues to grow within us. Again, this is not meant to be a burden, but a means of God's grace and love in our lives. God desires to be in relationship with us, because God loves us and has given us a love for him. God makes it possible for us because he is at work in us.

Let us remember that there is a communal aspect to Paul's words of encouragement. Although there is a personal aspect to what Paul writes, there is also the communal aspect to continue obedience to the Lord and live out the faith God has given us. Believers in Jesus Christ are called to do these things together as the body and bride of Christ. Living out one's faith does not happen in a vacuum or in isolation. You and I are called to help one another stay connected to God. When we see a brother or sister in Christ fall, lag behind, or start going astray, we lift one another up to work together and point each other in the right direction.

If you struggle to read your bible consistently, form a group of people to read it with you. You do not even need to meet constantly, we have social media, texting, email. Use that to hold each other accountable. If you struggle with going to the Lord in prayer, then meet with other people on a regular basis to pray together. You might even learn how to pray out loud and not be embarrassed. Whatever area of discipleship that you might struggle with, there are other people struggling with the same thing, and there are people who could walk along side of you as you grow closer to God. It is easy to make excuses, not so easy to reach out and ask for help.

God calls us all to maintain our relationship with him, not as a burden, but as a means through which he pours out his grace upon us. It should be our joy to have as our daily practice reading the bible, spending time in prayer, worshipping the Lord, and having fellowship with other believers. God will bless you and challenge you through those practices, but it is all part of growing closer to him and being set apart as God's people.

As Paul encourages the people in Philippi, so too I encourage you to "work out your salvation with fear and trembling." Live out your faith with awe and reverence to God. God has given you salvation through faith and will continue that work of salvation in you until Christ comes again. Thanks be to God that this is not a burden placed upon us, but a means through which he pours out his love and grace.

Classis Heartland Cornerstone Report:

The Ambassador Board of Cornerstone Prison Church and the council have been patiently waiting for the Holy Spirit to lead in this church behind the walls of the South Dakota State Penitentiary. We have been actively searching through the past 9 months for a servant leader/leaders for this church.

We have been continuing worship services and Bible study on the inside since our former pastor left in October of 2020. Gord Dyk was allowed to replace Pastor Doug De Groot and continue with the Monday night Bible study and Friday night worship services in the prison. The Bible study is currently being led by an inmate with Gord facilitating this inmate. The Friday night messages were via a video recording by different ministers in the area. Visitors were allowed to come back into the prison on May 24, 2021. Pastor Cory Grimm has been serving as our worship coordinator for the past 8 or so years.

We started our search for a pastor by putting an ad in The Banner which produced 4 possible candidates for the position of pastor. We interviewed them via Zoom and sent our inquiries from former churches of these men. We eventually were led by the Spirt to two prospects which we interviewed for a second time. We also asked them to produce sermons which were again done via video for the congregation at Cornerstone to see and the board to evaluate. After this process, one man decided to withdraw his name and at that time our worship coordinator was interested in the position since we were looking at two pastors to fill this role at Cornerstone instead of just one.

We decided to call Pastor Scott Van Voorst from the Friendship Community Church in Sergeant Bluff, IA and Pastor Cory Grimm from the American Reformed Church in Primghar, IA. Pastor Scott has accepted our call but Pastor Cory through much decision decided to decline the call because the timing was not right for him and his family. We are hoping to have Pastor Scott start on September 3, 2021, with his installation service sometime after that in September. As far as a second pastor, we are putting that on hold for the time being.

We ask for the continued prayers of classis for the Ambassador Board, Cornerstone Council and congregation as we move into a new place with Pastor Scott Van Voorst as our servant leader for this church behind the walls of the SDSP.

We would also like to update you on the commissioned member piece, which we at Cornerstone have been working on with the help of Rev. Bernie Haan, our classical counselor, and the Celebration Fellowship Church in Ionia, Michigan which has 3 different churches in various prison facilities. What this consists of is the possibility of members at one church on the outside being able to be commissioned members at a church on the inside. Here are the guidelines for this concept:

- The members on the outside will maintain a dual membership specifically they will be officially commissioning the professing member per his/her request to become a commissioned member in the ministry of the Cornerstone Prison Church.
- The commissioned member remains a professing member of the home/sending church for Sunday worship, spiritual formation, discipleship training, Christian fellowship, mutual service and pastoral care. A commissioned member remains under the supervision of the elders and council that holds his/her membership. The home church includes the person requesting this commissioned membership in their report to the denomination of total professing members and computation of denomination and classical ministry shares.

- The commissioned member agrees to participate in the life of the Cornerstone Prison Church in various ways (examples: attending Friday night worship services, participation in a Bible study group, promotion of the ministry I his/her home church, involvement in a prayer ministry, contributing financially to this ministry)
- A commissioned member (male or female) is eligible to be on the Ambassador Board.
- A male commissioned member acknowledges that he is eligible to be an elder or deacon of the Cornerstone Prison council provided he is not currently an office bearer in his home church.
- Commissioned member status can be concluded by written notice of the home church, the commissioned member and/or the Cornerstone Prison Church.

We at Cornerstone are asking for classical support and approval of this idea. Thanks
Ambassador board and Cornerstone Council.

REPORT OF THE CLASSICAL MINISTRY LEADERSHIP TEAM TO CLASSIS IN SESSION, Wednesday, September 22, 2021 AT Sibley Christian Reformed Church in Sibley, Iowa.

WRITTEN REPORT:

Esteemed Delegates:

Since the last meeting of Classis of the Heartland on March 2, 2021 your Classical Ministry Leadership Team met on Wednesday, July 22, 2021 at Living Water Community Church in Orange City. Rev. Loren Kotman, Rev Garry Nyenhuis, Randy Smit and Darrell Teerink were in attendance. We began the meeting with prayer. The following matters were discussed and processed by the committee.

- 1. We reviewed the decision of the March classis to approve the following award.
 - \$5000 to Jamie Negus for the 2021-2022 academic year. This will be his fourth year as a
 part-time student at Sioux Falls Seminary and his third year that he receives assistance from
 classis.
- 2. We reviewed the financial statement for the committee.
 - The CMLT balance as of January 1, 2021 is \$16,692.
 - \$5,000 has been paid out for the 2021-2022 academic year leaving a current balance of \$11,692
 - Expected ministry shares for 2021 are \$6888.
- 3. We reviewed the status of students who have received assistance. Ben Wiersma graduated from Sioux Falls Seminary and was declared a candidate in the CRC in June and has received a call from Sibley CRC. No new former students who have received aid have met the 10 year active ministry requirements for receiving assistance since those noted at last year's meeting.
- 4. CMLT has contacted the three individuals who are currently licensed to exhort in our classis. Sherwin Bolkema and Kurt Rietema would like to have their license renewed. Greg Steggerda asked that his license not be renewed. We are grateful for his years of service in our classis.

ITEMS FOR CLASSICAL ACTION

1. Recommend that we decrease the per member classical share from \$2.50 to \$1.75 for the year 2022.

Rationale:

- We currently have one student that we are supporting. We have an adequate reserve should more students apply next year.
- 2. Recommend that classis renew the licensure to exhort for Sherwin Bolkema (712-737-8183), and Kurt Rietema (913-219-9498)

Classical Safe Church Team Tasks:

- The Safe Church Team serves in a consultative role for churches who are developing (or reviewing/revising) congregational safe church policies.
- The Safe Church Team serves as a resource for churches dealing with allegations of abuse.
- The Safe Church Team serves as a clearing house of best practices and periodic trainings for Classis Heartland and Classis Iakota regarding abuse awareness and prevention.

Team Meeting: 06/29/21

lakota and Heartland team members met to address agenda items which consisted of introducing new member (Henry Lengkeek), discussing the replacement of a Heartland team member (Del Walinga), a review of recent advisory panel outcome and process, upcoming trainings and classes meetings, and goals for our committee.

Safe Church Committee Activity

In May, Tara was approached by a church to help address an abuse allegation made by two claimants/congregation members towards church leader. Tara served as an advocate to the two claimants and Jesse Walhof was trained in the advisory panel process and sat on the panel to hear the testimony of the claimants and the accused. Jesse also participated in the rigorous process of writing the final report and recommendations. The final report was distributed to the claimants, the accused, and the church leaders on 06/16/21. The church has received the findings and recommendations from the advisory panel and are being asked to promptly follow through with the recommendations.

We will be hosting an Advisory Panel Training where church leaders and congregation members can be trained to serve as an advisory panel member. The purpose of the advisory panel is to address disclosures of abuse by listening to the testimony of claimant(s) and the accused and make recommendations to all parties based on current safe church policy. This is a necessary and needed component of maintaining a safe and fair environment for victims and those that are accused of abuse. Please be attentive to upcoming emails from Tara regarding dates and times and consider those in your congregations that may do well serving in this role.

Please consider following <u>"The Networks" safe church blog</u> for ongoing training and education opportunities on this topic. Also, be aware that "Abuse Awareness Sunday" which will be on September 26. This is an opportunity for you to educate your congregation on abuse and safe church matters. The CRC Safe Church website offers resources to your safe church teams and leaders to distribute on this day.

Safe Church Team Goals:

Safe church team goals remain that each church in the lakota and Heartland classes have a 2–3-person safe church team, have an updated policy, and establish background checks for all of those that care for children and teens in their ministry programs.

Please ensure that if an allegation of abuse surfaces in your church, you contact the safe church team before approaching the accused.

Troy is a Western Christian and Dordt graduate and was the Coordinator for Minnikota Youth along with Dawn Ryswyk for 10 years before I took over (along with Kandace Brands from 2010-2015). Between sets we listened to the testimonies of two dear friends of mine: Caitie Fagen and Sean Baccam. Caitie Fagen is a 2020 graduate of Dordt University and is currently a Youth Director at the Sheldon 1st Reformed Church. Caitie was a DU Student Leader for the MIK Youth Jr High Retreat for 4 years and helped out with a handful of other MIK Youth events during her four years at DU. Sean Baccam is a lifelong volunteer Youth Leader at 1st CRC in Hull. Classis Report: Fall 2021

Apart from the Chicagoland Classes, the Central US team partners with seven Classes—Central Plains, Heartland, lakota, Lake Superior(US), Minnkota, North Central lowa, and Wisconsin. Here are a few glimpses into the mission activity in each Classis.

Central Plains:

New Life Prison Ministry and Rick Admiraal have been deeply affected by the pandemic, since access to the facility in Newton was unavailable. Pray for momentum to increase when they are able to meet there again.

Resonate's journey of discernment called Go Local has been helpful to Grace Fellowship as they engaged spiritual practices (listening, discerning, experimenting, reflecting), while engaging their neighbors.

Some other individuals in congregations of Classis participated in Joining God in the Neighborhood, a 4 session taste of the Go Local process.

Trinity, St. Louis, has embraced a Koren group using their church building. This hosting of an ethnic group is another way to love our neighbor different than you through hospitality.

Heartland:

Scott Van Voorst has taken a call to the Cornerstone Prison Ministry. Friendship Church is being assisted by the Classical Mission Committee for its future plans.

Kansas City area has New City Church working toward another site in a neighboring part of KC, MO and Kurt Rietema continues to develop and practice presence in KC, KS Argentine neighborhood.

F Street Church in Lincoln continues to find ways to blessits community through multiple ministries and to raise leaders for the mission of God there.

lakota:

Journeys to Friendship, a cohort of like minded folks who focus on loving their neighbor different than themselves, is planning their June 2022 conference in NW IA/Sioux Falls SD. This group meets monthly to plan the event and also hear stories from around the world around international students, immigrants, refugees, and ethnic diversity. This would also be of interest to Heartland and Minnkota.

The Central US in partnership with Journeys to Friendship is looking for a Mission Network Developer in NW IA/ Sioux Falls SD area to help spread the word and assist on the ground planning for the conference. It is about an 8 hour per week job commitment. If you are interested or can suggest a person for this let me know at pkelder@crcna.org

Hope, Rapid City is working through At the Crossroads, a process that helps them celebrate their past, name their present and discern their future. Pastor Joy Englesman is assisting them I the process.

Lake Superior:

Trinity Hill in Chanhassen MN is a partner with Classis and Resonate as a new ministry. Kyle Sandison is stepping into a greater role of leadership there.

The Broken continues to minister to those freed from addiction or prison in Willmar MN. The Central US team would invite further discussion with them in the year ahead.

There is some interest in bringing the Deeper Journey retreats to this Classis. Further discussions are pending.

Minnkota:

Minnkota was seriously working in Marshall MN as a new ministry site. Pray for an opening so that this might continue in the months ahead.

North Central IA:

The campus ministry Areopagus led by Tyler Helfers at Iowa State University is supported by NC IA and others in the state.

lowa State also hosts a Korean ministry which is going through a transition right now. Pastor Lee is returning to Korea and rev. S Kim is coming to take the campus position there.

Kanawha participated in the Go Local cohort. Their experiment during the pandemic was with their children's ministry and it grew to 65! Recently they planted a pumpkin patch near the church and look forward to a fall harvest.

Wisconsin:

Geneva Campus Church at the University of Wisconsin is entering a new chapter. Jim Kirk becomes the lead pastor as Mike Winnowski retires. Geneva wants to keep a focus on the campus, especially with graduate students (over 10,000). The vision is to hire a second person for that purpose. Classis is being asked to partner with Geneva for this person.

Go Local and Joining God in the Neighborhood has been well received by Faith, Beaver Dam and also Marshview Ministries. A number of lay leaders in Oostburg and Waupun participated in Joining God in the Neighborhood.

A unique partnership is being formed by First, Oostburg and Kenosha CRC. This looks to be a foster/adoption merger. Pray that God can use this to benefit both congregations.

Central US Region

Calvin University board notes Feb/May 2021

The board meeting February 4,5 was held virtually. The minutes from the October 2020 meeting were approved with minor changes as well as correspondence received and sent.

Michael Le Roy shared with trustees the details related to Calvin's potential bond restructuring. Calvin's important characteristics shared with the raters were:

- Calvin has a strong national and international reputation among Christian higher education, and Calvin's faculty shapes the conversation around faith and learning.
- Calvin has a strong, seasoned leadership team that has demonstrated its capacity to respond to adversity.
- Calvin has outstanding balance sheet, demonstrated fiscal discipline, and strong donor support.

Joel Westra, Co-chair of the University Core Curriculum Task Force, provided an overview of the work of the task force and noted that the existing core lacked internal coherence and was adjusted to work for various programs. He shared that the revised core is intended to provide versatility to students as they seek to satisfy requirements. The proposal for the revised core was ratified by the Board and will be implemented this Fall.

The Board then moved into a discussion on the work of the Confessional Commitment and Academic Freedom (CCAF) sub-committee related to the CRCNA human sexuality report that was shared by the denomination in October 2020. The CCAF is gathering information that can be presented to the board in May to help them understand the potential impact of the study. The discussion hinged on the difference between Reformed confessions and denominational position statements and what the implications are to the university. The board agreed that the CCAF sub-committee should continue their review and discernment in the matter and that they bring their findings back to trustees.

All trustees reviewed individual committee minutes prior to plenary IV, and several items of note arose during the committee Q & A time:

- Administration and Finance: Trustees will need to look at strategic budget planning, as the university will need to make substantive adjustments to produce a balanced budget for 2021-2022 in May.
- Enrollment Strategy: Calvin needs to keep increasing the recruiting funnel, and trustees were invited to help in the recruitment process. Materials will be sent to trustees.
- Executive: Nominations are open for officers. The secretary spot will be open. Send suggestions to Jan or Bruce.
- Trusteeship: The bylaws are being revised. The board officer structure has been modified to have a chair, vice-chair, and secretary. The duties of the secretary are for oversight and operation, while the day-to-day duties will be supported by administrative staff. The university president will be appointed by the board. Also, represented regions will move from 12 to 6. Bylaw changes need a 2/3 approval of the board and majority approval by the Council of Delegates of the CRCNA.

- AA 3.160 Faculty Reappointments with tenure was approved.
- AF 3.116 2021-2022 Capital Budget Proposal was approved.
- AF 3.117 Debt Refunding Resolution Revision was approved.
- AD3.004 Athletic Stadium Fundraising was approved.
- TR 3.037 Board of Trustee Handbook Revisions to Section II was approved.
- TR 3.038 Bylaws Revisions was approved.

The consent agenda was ratified, endorsed, and approved with no opposing votes

Board meeting for May was held virtually.

After a review of the agenda and approval of the February 4-5, 2021, minutes and correspondence at Plenary I, Chair B. Los thanked Cabinet members and made personal comments of his appreciation for each of them.

Plenary II started with President M. Le Roy introducing Calvin's new provost, Dr. Noah Toly. Dr. Toly shared a bit about himself, his family, and his faith journey. He noted that he moved many times in his youth, so he gained exposure to different Christian traditions and started to establish his Reformed roots. Through it all, his immersion in scripture is the catalyst through which God works His way in him.

M. Le Roy then shared things at Calvin in which he finds joy and gratitude:

- Enrollment is on-track to meet the FTIAC goal of 725.
- Pandemic operations have been on-point and have helped Calvin students to be able to continue to meet on campus. The board authorized the conferral of degrees, honors, and certificates for the class of 2021.
- There is growth in awareness on campus of what it means to be a person of color in a predominantly white community.
- Fundraising continues to be outstanding: \$199 million has been raised for the campaign, \$28+ million for the Commons union, \$2.7 million for the annual fund, and \$29.5 million in new gifts and pledges.
- The structural aspects of the budget are being adjusted, but Calvin does have a balanced budget planned for the coming year.
- The debt structure has been simplified through a bond offering. Calvin received an A- rating from S&P.
- The university held a groundbreaking for the new business school this spring and building has commenced for this facility. A new dean, Dr. James Ludema has also been appointed to lead the School of Business.

Trustees heard a presentation on "Finance 101: Revenue" from J. English, L. Jensen and K. den Dulk. The

presentation highlighted the distribution and sources of revenue for Calvin, the challenge of decreasing net tuition revenue from traditional undergraduate students, and the university response in working to expand our markets for undergraduate students and developing graduate programs that attract new learners.

The board then engaged with several students of color (Samuel Carrasco, Frank Jones Jr., and Shelton Rodriguez) who sit on the students of color presidential advisory council. Each shared about their Calvin experience and what they would like to see at Calvin related to racial reconciliation. The board was both inspired and grateful to these students and Dr. Michelle Loyd-Paige for this excellent presentation.

Since the board meeting in May, Jim English the VP of Finance has left the university to pursue another opportunity. We are grateful for the good work that Jim accomplished during his tenure at Calvin to balance the budget during the challenges of COVID and enrollment challenges.

President LeRoy also notified the board after the May meeting the 2021-2022 academic year will be his last year of leading Calvin. Calvin Theological Seminary Report for Classis – Fall 2021

Region 8 Trustee - Rev. Robert Drenten

Noteworthy items from the Board of Trustees meeting of May 20-21, 2021:

<u>Facility Remodel and Expansion</u> – Calvin Theological Seminary broke ground on a new addition to the building. An extensive upgrade is underway on the facilities to upgrade classrooms; to improve spaces for students, faculty, and staff; and to enhance the hospitality of the building and grounds. The project also addresses some maintenance issues.

<u>Students and Academic Programs</u> – The student body represents a diversity of nations. CTS anticipates welcoming a student from Cuba this year. We thank God for the international impact CTS is making. We are also thankful for the experience interaction provides students during their years at CTS.

52 graduated from CTS in May 2021 with degrees ranging from certificate-level to masters and doctorate degrees. This included 22 Master of Divinity graduates. M.Div. graduates often seek candidacy for ministry in the Christian Reformed Church.

CTS sees three trends in enrollment which may be related. First, CTS is receiving a declining number of applicants for the M.Div. program. Second, students preparing for ministry increasingly pursue a more narrowly-focused Master of Arts degree. Third, applicants increasingly seek out distance learning options. These trends hold true for applicants to most seminaries across North America. Applicants tend to be older, less free to commit to in-resident education, and interested in accessible tools for ministry.

CTS is in a strong position to adapt to the context of these trends. The Lord has blessed CTS with a heritage of quality education and with financial health. The Lilly Foundation has awarded a \$50,000 grant for a CTS initiative, "Pathways to Tomorrow," which will explore ways to realign its programs in the future.

<u>Staff and Faculty</u> – The board approved 3-year reappointments to Jeff Sajdak as Dean of Students, and to Sarah Chun as Dean of International Students & Scholar Services.

CTS has begun a search for faculty positions in Old Testament, History of Christianity, Philosophical Theology, and Preaching. Be in prayer that the Lord provides professors for these positions. Be in prayer also that the Lord will use new faculty members to continue to give shape to the vision and life of CTS.

<u>Calvin Prison Initiative</u> – CTS continues to provide help and resources to give prisoners training in ministry leadership at the Handlon Correctional Facility in Ionia, Michigan.

<u>Resources</u> – Please take advantage of *Forum*, a resource published quarterly by CTS and sent to Christian Reformed churches. *Forum* provides helpful study material for church councils and members.

Also, please explore the resources available through the Calvin Theological Seminary website -- http://calvinseminary.edu/. The site offers a number of tools for preaching, worship, and ministry leadership.

Finally, encourage those around you who you notice may have gifts for ministry to explore the Lord's calling in their lives, and to consider Calvin Theological Seminary as a key part of their preparation.
