The Classical Home Missions Committee convened on two occasions subsequent to the most recent Classis meeting, meeting together on October 12, 2022, in attendance at that meeting were Kevin Muyskens, Keith Hoekstra, Gary Hibma, Allan Kramer, and Jeff Heerspink. The second meeting took place on January 25, 2023 in attendance at that meeting were Kevin Muyskens, Keith Hoekstra, Jeff Heerspink, Allan Kramer, Gary Hibma, and Mark Volkers. Each of the meetings opened with prayer, held in accordance with the requirements of church order for classical meetings, and closed with mutual prayer.

# ITEMS FROM CLASSICAL HOME MISSIONS COMMITTEE MEETINGS

The committee had the opportunity to visit with Lora Copley via zoom meeting to discuss Areopagus Ministries, the campus ministry serving the Iowa State University campus in Ames, IA and the students there. She shared many of the opportunities that she continues to experience to disciple students there, including small group, apologetics groups, Bible studies, working on building a Reformed connected student group, as well as helping with Iranian Family Home Aid. Another goal that Lora shared with the committee was a desire to create connection opportunities with local churches that surrounded the ISU campus.

Sage Peterson completed the work as a part of the Residency in Lincoln, in response the success that they experienced with the program, Willow Applegate applied to participate in the residency program in continuing the process of encouraging and equipping future leaders of the church for the work of discipleship. There is clear evidence of the working of God in the activities and progress of the program.

The committee also discussed church planting activities, the transition of the Sergeant Bluff congregation to Elevate is going well, the committee desires to continue to be connected with the congregation and it's leaders as they continue to worship together, and rejoice that God has brought to them a Senior Pastor in Joshua Camping. We rejoice also in the commitment of New City in Kansas City to proceed toward the work of planting a church. The committee plans to take an opportunity to visit New City and encourage them, the committee also approved funds in order to support this goal. F-Street Church in Lincoln is preparing itself to move from an emerging congregation to an organized congregation. The committee rejoices in the continued growth of the congregation and celebrated the work that God is doing there including ministries like Indwell, Immerse, a new vision that they are exploring in serving the community, and the work that God is doing through the residency program.

Kevin Schutte from Olathe has shared with our committee the incredible missional activities that are happening there. The church there is seeking to be a community member in wonderful ways, offering their space to serve other church groups, imagining a community where the church shares neighborhood with a community of homes from Habitat for Humanity. The committee would like to visit along with our visit to New City.

The committee discussed our connections to the prison ministries in the area, we encourage our committee and our congregations to find ways to engage in serving those ministries.

Delegates of Classis Heartland,

In response to the Synod Review Task Force, Synod 2019 adopted several changes to "how we do synod." While many of those changes apply to procedures at Synod there are, however, a few that apply to how we as a Classis select our delegates for Synod. Recommendation m., which was adopted by Synod 2019 reads, "That synod encourage classes to send one or more delegates to synod for two consecutive years, if possible, to build continuity from synod to synod." (Acts of Synod 2019, pg. 809-810)

Our hope is Classis Heartland would honor this encouragement from Synod as part of our Synodical delegation selection process. Continuity is important especially in light of the issues our denomination is facing. Therefore, if our delegates from Synod 2022 are willing to serve once again, we would like to encourage them to do so to provide continuity.

It is our hope that we would begin our Synodical delegate selection process from here forward by asking our Synodical delegates who have not served two consecutive years if they would be willing and able to serve a second consecutive year. Once this part of the selection process is satisfied, then we can begin with our normal balloting procedure.

If it is Classis' will that this become normal procedure for Synodical delegate selection, our delegation would be willing to make a motion from the floor to that affect.

# Overture from the Northern Lighthouse Church to Classis Heartland

Northern Lighthouse Church requests Classis Heartland to approve the organization of F Street Church according to article 38-b in the Church Order. We are so excited to see what God has done through this ministry! The Church Order lists several grounds for organization, and we believe that FSNC qualifies under these grounds.

# A. Ordinarily the congregation shall have been in existence at least three years.

F Street Neighborhood Church was planted over eight years ago. The first worship service at FSNC was held on, June 1st of 2014. Since 2014, the F Street congregation has continuously met and has grown in many ways (numerically, in new outreach avenues, and in effectiveness for serving Christ).

B. The congregation shall include a sufficient number of members who meet the Biblical requirements for church office and are committed to use their personal and spiritual gifts in providing leadership and support to the congregation and its ministry.

F Street currently has four men serving in a Leadership Capacity, whose gifts and leading have been affirmed by the congregation, and who meet the Biblical requirements for Elders. FSNC also has more individuals attending who could serve in the role of Elder potentially, and as a congregation they are in the process of adding additional leaders at this time.

FSCN also has "Team Leaders" (those who oversee various areas of ministry) who meet the Biblical requirements for Deacons and would be considered so moving forward, following the organization process.

C. The congregation exercises financial stewardship for the continuing development and effectiveness of its ministry and, prior to organization, provides the classis with financial information that reflects its capacity and commitment toward financial self-support, including personnel expenses and classical and denominational funding support.

F Street has finished every year above budget. F Street has also added staff (all of their ministry staff raise 50% of their own support) and has been able to make significant improvements to its facilities in the last few years. F Street has seen yearly growth in local giving and although the church receives, by God's provision, much outside support, they have received only \$5000 from Classical Home Missions in past several years (Indicating they are not financially dependent upon the denomination).

<u>D. The community in which the congregation is located offers the potential for continuing ministry, and the congregation gives evidence of its continuing commitment to fulfill the great commission with the resources and opportunities God gives.</u>

F Street was planted in the Near South Neighborhood in Lincoln, NE (just south of downtown). F Street seeks to follow God's call to serve in very practical ways within this neighborhood. There are many in the neighborhood who have experienced a lot of hurt and brokenness (due to Homelessness issues, Sex Trafficking, Loneliness, Poverty, etc.). Because of this call to the neighborhood, there are many opportunities to share the hope and the transformative power that the Gospel offers both for this life and for eternity. As a church, they have had an average of five Adult Baptisms per year. Their ongoing prayer is for more workers – because the Harvest is plentiful!

At a recent F Street congregational meeting, strong support was given toward becoming an organized CRC church. A great deal of gratitude was also expressed for all of the support and encouragement that have been provided by Classis Heartland since F Street was planted.

# **Overture from Living Water Community Church to Classis Heartland**

# Background:

On October 28, 2022, Calvin University's board of trustees voted to allow faculty members with confessional difficulties on human sexuality to remain in good standing within the institution. The board decision was characterized as "respectful of the university's covenantal partnership with the Christian Reformed Church in North America, consistent with confessional commitment, congruent with existing policies and procedures, supportive of academic freedom, and reflective of constructive engagement."

This has allowed faculty who have filed gravamen the continued ability to teach, work for, and minister to students, while at the same time allowing those same faculty to hold positions in opposition to our Confessions. Furthermore, the board's decision is, in fact, contrary to Confessional commitment and also negates the authority structure set in place for how gravamen is to be handled by the institution.

Therefore, the Council of Living Water overtures Classis Heartland to Overture Synod 2023 as follows:

To withhold all denominational funding from Calvin University beginning on September 1, 2024, with the provision that the University will be funded after this date upon the full adherence, without exception, to our Covenantal standards by all faculty and staff members of Calvin University.

# Grounds:

- 1. Synod 2022 affirmed the Christian Reformed Church's traditional understanding of unchastity as found in the Heidelberg Catechism Q and A 108, and this understanding has confessional status.<sup>2</sup> This decision was made by the majority of Classes at Synod, and it is considered "settled and binding".<sup>3</sup> As this is the position of the Christian Reformed Church, the decision made by Calvin University's board of trustees, as outlined above, directly opposes the understanding of the Christian Reformed Church. Therefore, Calvin University can no longer be funded by the Christian Reformed Church as the covenantal relationship shared between the institutions has been severely damaged.
- 2. The decision by Calvin University's board of trustees is contrary to the position taken by 74 percent of the delegates to synod that represented much of the denomination.<sup>4</sup> As the action by the board of trustees is incompatible with the Christian Reformed Church, Calvin University and the values and beliefs it holds are no longer representative of the denomination.

- 3. The Calvin Faculty Handbook states that "Under the authority of Synod, the Church assigns authority for the life of the University to the Board of Trustees. The Board of Trustees, in turn, assigns authority within the University's governance system, in which decisions about personnel and confessional interpretation are assigned to the Professional Status Committee (PSC)." Thus, authority for the registering of gravamen falls ultimately under the authority of Synod. As neither Synod nor the Council of Delegates has received or reviewed any gravamen of either the confessional-difficulty nature or the confessional-revision nature, Calvin University has not adhered to the necessary policies and procedures; thereby further illustrating Calvin University's desire to no longer be overseen by the denomination.
- 4. Confessional-difficulty gravamen are intended to be a "personal request for information and/or clarification of the confession."<sup>6</sup> In the case of confessional-revision gravamen, "the burden of proof, therefore, rests upon the signatory who calls upon the church to justify or revise its confessions."<sup>7</sup> In both cases, gravamen are intended to bring clarity and/or change our confessions. Calvin University faculty and staff have not used gravamen in this manner but utilize them merely as a way of showing disagreement with the covenantal standards to which they must subscribe. Calvin University's board of trustee's decision to allow gravamen to be used in this manner further shows Calvin University's opposition to adhere to the Christian Reformed Church's confessional standards.

# Overture: Seat Female Deacons as Delegates at Classis Heartland Meetings

# Background

 Synod 2000 recognized two different perspectives in the CRC on ordaining women to serve in church offices and recognized both perspectives as honoring the Scriptures as the infallible Word of God. Therefore Synod 2000 decided (building on the decision of Synod 1995) that all CRC congregations may allow women to serve as ministers, elders, and deacons. Synod 2007 affirmed that individual classes may choose not to allow female delegates. Classis Heartland currently does not allow female officebearers to serve as delegates, though some congregations within Classis Heartland elect women to serve as elders and deacons.

# Overture

 The councils of Calvin CRC and Immanuel CRC Sheldon overture Classis Heartland to seat female deacons as delegates at classis meetings and to adjust section I.D of the Rules of Procedure accordingly so that those congregations who choose to have women serving as deacons may be more fully represented in classis.

## Grounds

- We, the councils of Calvin and Immanuel, are committed to Classis Heartland and desire to fully participate in classis meetings. As a smaller congregation with a smaller council than many congregations within Classis Heartland, Calvin has a smaller pool of currently serving church officers. We recognize that this issue affects not only Calvin but may also affect other churches in classis. Allowing smaller churches who are in a similar situation to ours the freedom to delegate female deacons would increase the likelihood of us having both an elder and a deacon who are able to serve at each classis meeting.
- Since this matter was last discussed in Classis Heartland in 2019, more women have begun serving in leadership roles within classis. For example, Immanuel recently ordained a female deacon.
- Women can be nominated for and serve on committees of Classis Heartland, and through their nominations and service we have seen women's gifts being utilized in many roles within classis. We believe that the seating of women as delegates would allow for classis to fully utilize the many types of spiritual gifts God has given to His church.

Please note, we are NOT asking any congregation to change its practice when it comes to ordaining women to serve on its council. We respect that there are two perspectives and deep convictions, and we want each council to have full authority to nominate its own minister, elder, and deacon delegates according to Church Order Article 40a. We simply ask that Classis Heartland acknowledge all the deacons ordained and delegated by the council they serve—whether they are male or female—and allow them to speak, vote, and represent their congregation at meetings of Classis Heartland.

# REPORT ON THE WORK OF THE CEC

**Esteemed Delegates:** 

The Classical Education Committee met on September 7, 2022 and January 11, 2023. Members present at each meeting were Rev. Aaron Gonzalez, Rev. Jesse Walhof, and Rev. Ben Wiersma. Rev. Gonzalez opened with devotions and prayer at each meeting. Each meeting was closed in prayer.

Topics discussed at the meetings included:

- 1. Providing Continuing Education
- 2. Ministry/Support on behalf of Classis Heartland
  - a. Classis Prayer Coordinator (Ms. Barb Hibma)
  - b. Minn-I-Kota Youth Network (MIK) (Ms. Lee DeGroot)
  - c. Safe-Church Team Heartland and Iakota (Dr. Tara Boer)
- 3. Financial Reports

Details of items discussed:

- 1. Providing Continuing Education
  - a. <u>Timothy Leadership Training</u> The CEC has been in contact with Sam Keyzer, Del Walinga (T.L.T. facilitators in Heartland) to help promote and support upcoming T.L.T. events.
    - i. TLT had a Summit gathering on October 28-29. The CEC gave a \$1500 grant to cover the cost of the event.
    - ii. No future dates have been announced at this time.
  - b. <u>Dordt and Classis Heartland Opportunities</u> The CEC will remain in contact with Rev. Todd Zuidema at Dordt University in order to partner with them in educational events.
  - c. <u>Dunamis Project</u> The CEC is promoting these events held each spring and fall at Ingham Lutheran Bible Camp in Milford, IA. Information about the events will be sent out through the Stated Clerk. The CEC encourages each church to promote these events and help support the cost of the event for their congregation members. If a church is unable to support financially, please contact the members of the CEC for assistance.
  - d. <u>Abide Project</u> The steering committee for the Abide Project is in discussion about future events. Online opportunities are available on their website (<a href="https://www.abideproject.org/">https://www.abideproject.org/</a>). These include articles, devotionals, and podcasts. The CEC discussed what the ongoing relationship with Classis Heartland and the Abide Project would look like.
- 2. Ministry Support on behalf of Classis Heartland
  - a. Classis Prayer Coordinator (Ms. Barb Hibma)
    - i. Ms. Hibma brought a couple of ideas to the CEC.
      - 1. Ms. Hibma shared the Prayer Wall that is currently being used at Living Water Sheldon.
      - 2. Ms. Hibma is planning to attend a Prayer Catalyst Gathering at All Nations Church in California. The CEC passed a motion to fund travel, lodging, and other expenses from this trip. Estimated cost is \$1700 from the Prayer Coordinator Fund.
  - b. Minn-I-Kota Youth Network (Ms. Lee DeGroot)
    - i. MIK Youth Network has received a donation of \$22,500 from Hope CRC in Rapid City, SD. The MIK Youth board has decided to use those funds for future scholarships for youth leader training events.

# c. Safe Church (Dr. Tara Boer)

- i. New information concerning Safe Church Policy compliance in the CRC has been sent out.
- ii. The CEC discussed how to best support the Safe Church Team, churches, and Church Visitors in the role of Safe Church Advisors.

Grounds: The Abide Project is a collection of CRC pastors, leaders, and church members who work to maintain biblical and confessional integrity through learning opportunities, prayer, and scholarship.

Recommendation 3: That Classis communicate with the Abide Project about hosting an event at either a local church or Dordt University in 2024.

Grounds: Many supporters and participants in the Abide Project events come from the three local classes.

# **Classical Safe Church Team Tasks:**

- The Safe Church Team serves in a consultative role for churches in classis who are developing (or reviewing/revising) congregational safe church policies.
- The Safe Church Team serves as a resource for churches dealing with allegations of abuse.
- The Safe Church Team serves as a clearing house of best practices and periodic trainings for Classis Heartland and Classis Iakota with regard to abuse awareness and prevention.

# **Team Meeting:**

A team meeting took place on October 25, 2022 to discuss outcome of classes meetings. The team discussed the proposed signing of the code of conduct policy by ministry leaders, concerns for churches who report physical safety concerns from community and congregation members, and training initiatives needed for leaders and churches as they create and maintain effective safe church practices. The team will meet again in February.

# **Safe Church Committee Activity**

Committee members continue to serve church leaders and congregations who ask for assistance and resources. Classes clerks forwarded an email and survey to churches for the purpose of understanding what ministry leaders need to support their safe church goals. Please complete this survey if you haven't already.

# Safe Church Team Goals:

The safe church team continues to ensure that each church have an updated safe church policy, conduct background checks on ministry leaders, and maintain a 2–3-person safe church team to over-see the policy. Ministry leaders can further prevent abuse by implementing the CRC supported <u>Circle of Grace</u> programming in their Sunday school classrooms. This curriculum takes 2-4 weeks of the year and provides age-appropriate education on boundaries, safe behaviors with others, the internet, and social media. Please contact Tara if you have questions about what services to use for background checks and how to get started with Circle of Grace.

Please also continue to follow the <u>CRC Safe Church</u> ministry page, blogs, and upcoming events. They offer many resources to ministry leaders and congregations in the form of education, training, policy formation, abuse prevention and response.

- 1. Membership: All present Rev. Kevin Muyskens (Chair), Rev. Nathan Kuperus-via phone call (Clerk), Rev. Brian Hofman (Vice-chair), Rev. Phillip Westra (Stated Clerk)
- 2. CIC invites Rev. Brian Dunn to serve as church counselor for First CRC, Hull upon Rev. Kotman's retirement.
- 3. CIC invites Rev. Ben Wiersma to serve as church counselor for Ocheyedan CRC upon Rev. De Does's retirement.
- 4. CIC accepts the request for classical appointment pulpit supply to Ocheyedan CRC and First CRC, Hull. They will be included on the schedule beginning January 2023.
- 5. CIC recognizes that congregations with pastors will be asked to offer them multiple times in 2023 for classical appointment to vacant churches.

- 9. CIC suggest the Diaconal Ministry Task Force to have three diaconally-minded lay people actively involved on the task force. If they need more people to fulfill this, the task force should seek additional members.
- 10. Motion duly made and carried to accept the transfer of ministerial credentials of Rev. Steve Boersma from Dispatch CRC, Dispatch, KS to Hawarden CRC.
  - a. Rev. Boersma was separated from the church in Dispatch, KS and is seeking a call. In the meantime, he and his wife have moved to Hawarden and are worshiping with the Hawarden CRC. It is fitting that ministerial oversight are transferred to the local congregation.
- 11. CIC instructs the Rev. Westra (stated clerk) to forward a reformatted version of the petition regarding Church of the Servant CRC of Classis Grand Rapids East hosting Synod in 2023 to the General Secretary and Council of Delegates.
- 12. CIC receives an appeal to classis regarding a council decision.

# 2. Old Business

#### 2.1. Successor to Siouxland Diaconal Conference:

Members of Classis Heartland have been developing a combined classical diaconal ministry. Tomorrow Kevin will meet with several people from Classis Heartland to continue discussing this after which he will reach out to Cliff Hoekstra (cah23@mtcnet.net) and/or Scott Hulstein (scotth@ntlifts.com) of Classis lakota. With refugees moving into the area, we see value in a shared diaconal ministry to potentially help in the process of welcoming and settling them.

#### 2.2. Minn-I-Kota Youth:

We are grateful Lee De Groot has decided to continue serving Minn-I-Kota Youth together with her husband, Doug. Stanley will ask the Minn-I-Kota board to submit their minutes to both CICs in addition to their bi-annual reports to classis.

#### 2.3. Safe Church Ministry:

Both classes have increased their remuneration for Tara Boer. We note that the denomination is currently welcoming feedback on the Code of Conduct.

# 2.4. Continuing Education:

Because Dordt University no longer hosts Day of Encouragement, we wonder about educational opportunities in our region. Stanley will encourage Todd Zuidema to ensure all pastors in area classes are notified of continuing education events that are offered through Dordt. The Classis lakota CIC and Classis Heartland Education Committee will discuss potential training for other leaders too, perhaps on alternating years (deacons one year, elders the next, lay-volunteers the next, etc.).

#### 2.5. Classis Renewal:

With the transition of denominational personnel, this initiative seems to be declining. That need not stop our two classes from sharing best practices as we're doing today.

#### 3. New Business

# 3.1. Synod 2022:

We sense that many people in our classes are content with the decisions of Synod 2022, particularly in regards to the Foundation-laying Biblical Theology of Human Sexuality report.

#### 3.2. Best Practices:

- Classis lakota has modified its procedures for delegating officebearers to synod, considering
  officebearers' gifts and welcoming individuals to be delegated two years in a row for
  continuity.
- 2. Classis lakota requested its licensed exhorters to sign the Covenant for Officebearers. The Classis Heartland CIC will consider asking its licensed exhorters to do the same.

- 3. Classis Heartland has been and will likely will continue having discussions about seating women at their classis meetings.
- 4. We discuss the size of our classes, noting that we are much larger than other classes. Some of our churches have as many baptisms as other entire classes. We wonder whether we should give thought to creating another classis in our region.

# 3.3. Affiliation:

Several RCA congregations recently expressed interest in affiliating with the CRC, most recently Maurice Reformed Church with whom John has been in conversation. John outlines the steps for affiliation, some of which could be characterized as onerous. We would welcome an overture to synod that makes affiliation more streamlined, even if it's only temporary as RCA congregations determine their future affiliations.

# 3.4. Ecclesiastical Partnerships:

We note that many area RCAs have joined or plan to join the Alliance of Reformed Church (ARC) or Kingdom Network. We discuss how we can maintain our partnerships with churches that have left the RCA both formally and informally. We see value in having conversations with area ARC and Kingdom Network leaders.

# 4. Closing

We see value in meeting at least annually to discuss (a) updates and best practices from each classis, (b) shared ministries (e.g. diaconal ministry, licensure to exhort, Minn-I-Kota Youth, Safe Church, etc.), and (c) opportunities for partnership (e.g. continuing education, overtures to synod, regional partnerships, etc.). # Classis Heartland Diaconal Task Force Proposal to Classis March 4, 2023

Committee to form a Diaconal Task Force Members: Jim Viet; Pete Attema; Jon Hellinga; Kevin Muyskens

- Structure: Task force would be headed by a volunteer chair/president/director along with 2-4 leaders in each area of Education, Mercy, and Benevolence. Thus the team would have between 7 & 13 members. (A smaller number is preferred for cohesiveness, but we would not want to turn away qualified volunteers.)
  - a. This will be a Classis Heartland ministry, hopefully with a mirror organization in Classis lakota with whom we could often share events, training, and best practices.
  - b. The Diaconal Task Force would be accountable to the Classical Interim Committee.
- 2. The following general areas of expertise will be solicited for the diaconal task force:
  - a. Education: to provide an annual deacons' training event, to be able to offer training to local churches in the areas of budgeting and leading people in giving.
  - b. Mercy: to provide leadership, organization, and coordination to help people of classical churches work together to meet a local or regional need: i.e. responding to the Parkersburg tornadoes or the Red River flooding.
  - c. Benevolence: to provide teaching in the areas of benevolence and personal financing. This could be teaching deacons or other church volunteers to teach/mentor others in the areas of persona budgeting and financial management. It could be hands on teaching with individuals in need of personal help in this area. It could include communication and cooperation with organizations such as Love INC in Sheldon or the Center for Financial Education in Sioux Center, etc.
- 3. Motion: To approve the foregoing structure and plan as presented.
- 4. The churches are asked to submit recommendations for the director of this task force to the committee.
- 5. Motion: To empower the committee to appoint a director with confirmation of the Classical Interim Committee.
- 6. Each church of classis is asked to submit 1-3 nominees for this task force. Nominees should be submitted to the committee by May 25. Churches are asked to communicate which area (education, mercy, or benevolence) for which their nominee(s) are gifted.
  - a. Nominees should be members in good standing in the CRC. They are not required to be currently serving as deacons.
- 7. Budget: We foresee seeking a \$5,000 (or \$2 per member ministry share) budget at the September 2023 classis meeting. Ideally as a money accumulates the annual request would likely decrease.
  - a. Possible expense items: speakers/trainers; travel expenses; printing & supplies; combined ministry expenses

Brothers and Sisters in Christ,

On October 10<sup>th</sup>, 2022 Rev. Nathan Kuperus and myself (Rev. Brian Dunn) visited the council of Living Water Community Church. This was done in accordance with Article 42 of the Church Order to ascertain whether the church as well as her officebearers were faithfully performing their duties, adhering to sound doctrine while observing Church Order and building up the body of Christ as their part in extending God's Kingdom. We are happy to report in our humble opinion, **Living Water Community Church is doing well in these areas**.

Living Water faces unique challenges as a multisite church in Sheldon and in Orange City, each of them being very different campuses. This makes for a unique flavor of ministry for each campus. In the past, this has presented leadership challenges for the council. Members from both campuses are present on the council overseeing the care and vision of the church. Therefore, they must be mindful of this uniqueness in their discussions and activities. Over the past three years, they have worked hard to bridge these gaps which has allowed for the unique ministries of each campus to flourish. In addition, the council is very pleased with the work of their pastors and Pastor Garry and Pastor Jesse echoed the sentiment toward the council. They have worked hard to communicate well including regular evaluations and encouragements.

Like many churches today, they too are facing many challenges. Recovery from Covid and the issues therein still linger, though overall, they feel they navigated it well. They had already been working to stream and serve people where they were at prior to Covid, and this helped. Yet, questions of discipleship remain as they do for many of us in the church. First CRC, at this writing is currently without a Lead Pastor. However, they feel they are in a good place, as much of the leadership has stepped up to meet these challenges. This has allowed them to work closely with their church administrator (being grateful for her work) so things are not falling through the cracks. They have also been served by the work of their Pastor of Congregational Care, Jordan Helming. Visiting the shut ins of the church is a priority for First CRC. This is one of the primary roles Pastor Jordan fulfills. In addition, he has stepped up to preach a bit more frequently during the vacancy. The Council has been greatly please with this and his continuing work and are grateful he is on board, and he to work with them.

The Elders of First CRC still engage in regular family visitation typically making it through the entire congregation in 1½ years. While this is challenging, it maintains that strong line of communication and connection they need to thrive in the work they do. They are a group that is centered on promoting the pure preaching of the word and have worked hard to keep that organized during their vacancy. The Deacons handle their collections and deal with benevolence issues as they receive them.
