The Council of Ocheyedan Christian Reformed Church sends her delegates in protest to this assembly of Classis Heartland. While we affirm the gifts and talents that our Lord has given to women in the church, and how these gifts and talents can be used to greatly bless and serve the body of Christ; as it pertains to the offices of Pastor, Elder, and Deacon, the Scriptures are clear (i.e. 1 Timothy 3:1-13, and Titus1:5-9): these offices are to be held only by qualified men, of god-fearing character, in order to rule and govern the body of Christ in good order. Members of the body of Christ are thus called then to submit to the order which Christ has ordained for His Bride. In light of Scriptures clear teaching on this issue, and the current position of the Christian Reformed Church regarding this matter, we sit in protest to the seating of women delegates at this assembly.

Fall 2025 Church Planting Vision and Strategy

We give thanks that Synod 2025 prioritized church planting as a denomination. From this meeting, Resonate was tasked to develop a 10-year strategic plan to be presented to Synod 2026. In response to that, Resonate, in cooperation with Classis South East US, is asking every classis to participate in this important discernment work. Specifically, we're asking each classis to take the following actions in their fall 2025 meetings:

Call to Pray - A call to prayer and fasting is foundational for the 10-year strategic plan. We are asking classes to set aside November 9-16 as a week of prayer and fasting to seek the Spirit for a renewed church planting movement in the CRCNA.

Call to Share - Church Plants are as diverse contextually, culturally, and programmatically as the planters who lead them. An important part of developing a unified vision is hearing the heartbeat and hope of the current church planting work. We invite every pastor and planter to share their own experiences and insights through this <u>2025 CRC Church Planting Survey</u>.

Call to Participate - <u>November 9-11</u>, we will host a <u>Church Planting Vision Conference</u> at Sunlight Community CRC in Port St Lucie, FL. We ask that each classis identify and send 3-4 representatives to participate in this vital conversation as we discern together a renewed vision for church planting. Classis Heartland - Emerging Church Proposal - Fall 2025

Background

In 2014, Living Water Community Church felt the call of God to create a second ministry campus in Sheldon. For all these years, the campuses in Orange City and Sheldon have worked together to preach the gospel of Christ while under one council. We celebrate the years of mutual ministry and the building up of Christ's kingdom together. As is natural, the campuses have taken on their own identities with distinct styles of ministry and even increasingly independent leadership teams. Recognizing this, God has led the council of Living Water Community Church to this recommendation:

Proposal

The Council of Living Water Community Church (leadership of both Orange City and Sheldon campuses) requests Classis Heartland to approve Living Water Community Church, Sheldon as an independent emerging church under the temporary supervision of the council of Sanborn Christian Reformed Church. (see Church Order art. 38)

Grounds

- I. Living Water, Sheldon and Living Water, Orange City have increasingly independent leadership teams, ministry contexts, worshiping bodies, goals, and challenges that can be better managed as separate congregations.
- II. A financial study conducted by Living Water Community Church has shown that Living Water, Sheldon will be financially sound as an independent congregation. (As per CO art. 38) III. Sanborn CRC has agreed to become the supervising council of Living Water, Sheldon.
- IV. Granting a temporary emerging status under Sanborn CRC council's supervision allows:
 - A. Living Water, Sheldon to have time to establish a full council, leadership structures, and independent ministry programing.
 - B. Living Water, Sheldon to have time to establish an independent budget and financial structures.
 - C. Living Water, Sheldon to operate under the wisdom, guidance, and oversight of Sanborn CRC's council in the interim.
 - D. Living Water, Orange City to focus on their own unique ministries and the search for their next Pastor.
 - E. Both Living Water campuses to Pastorally lead their congregation through the changing relationship dynamics that will occur.

He has blessed them with faithful preaching from God's Word in the Psalms, Revelation, and others. They appreciate his courage in proclaiming the God Word in the difficult topics as well.
- The council is very thankful for
 - o The Young Mens Bible Study that has started
 - o The thriving GEMS ministry with over half of the participants coming from the community
 - o The youth ministry at the church

Challenges

- The council feels a challenge and opportunity to grow as a church in embraces members with special needs and enfolding them into the life of the congregation.
- There is a current prayer effort to discern the future needs of the church building and how to address them.
- The council senses a growing burden to seek ways to reach the unchurched people in their community in Sanborn.
- There is an ongoing challenge addressing the future of the evening service and reaching out to those who have not returned to in person worship and community presence after Covid.

Overall there is a genuine sense of community and comradery present on the council and a joy in doing the work of ministry. Sanborn enjoys worshipping and being in God's Word together and serving their community. They love their pastor and appreciate his ministry and seem unified in their efforts to glorify Christ in their context in Sanborn.

This was an enjoyable visit. We rejoice in the Lord's blessing on this congregation and pray with them regarding the fulfillment of their hopes for the future.

Living Water Community Church (LWCC)

We as church visitors have offered a listening ear and guidance through Living Water Sheldon's discernment and decision-making to become independent from Living Water Orange City. Below are some notes from our meetings with Living Water.

June 9, 2025

Rev. Phil Westra and Rev. Ben Wiersma were initially invited to attend a council meeting of LWCC. Rev. Wiersma was able to attend this meeting of the full council at Living Water Orange City.

- LWCC Emerging Church Discernment Team presented their recommendation to the LWCC council to proceed with a congregational vote on the Sheldon campus becoming an emerging church.
 - The team reported on their discernment process, financial projections, and several round table events.
- The council voted to proceed with the congregational vote after several congregational meetings to inform the congregation and discuss any questions from the congregation.
- The council also discussed the voting process for the two campuses and set a date for the congregational meetings and vote.

August 6, 2025

Rev. Phil Westra and Rev. Ben Wiersma attended one of the congregational meetings at Sheldon campus.

- This was the second congregational meeting held at the Sheldon campus (previous meeting was Sunday, August 3). The August 6 meeting was sparsely attended, but the August 3 meeting was much larger.
- The Sheldon campus elders and deacons presented their grounds for becoming an emerging church, the financial projections, and the process for voting.
- A few questions were asked and discussed.

August 11, 2025

Rev. Phil Westra attended a council meeting at Living Water Sheldon (just the Sheldon campus council members were present).

- They discussed feedback from their congregation through their discernment process for becoming an emerging church
- They finalized detailed plans for how the day of the vote would be handled

• They asked Sanborn to consider serving as their overseeing church during their season of emerging church status

August 25, 2025

Rev. Phil Westra and Rev. Ben Wiersma attended a full council meeting at Living Water Sheldon campus.

- The congregational vote passed.
- The council put together a document to present to Classis.
- The council discussed the process moving forward pending Classis approval.
- The two campuses plan to have a combined celebration event to commemorate this next stage as a church.
- The council discussed and came to a unanimous decision about how the assets would be divided between the two churches
